

## REQUEST FOR PROPOSALS (RFP)

# DRAFTING OF CMU DECREE FOR ESTABLISHMENT OF REIMBURSEMENT MODEL IN UKRAINE

The goal of this solicitation is to obtain proposals in the framework of activities related to the development of draft mechanism (model) of reimbursement of essential medicines, as well as draft regulatory and legislative framework to create a holistic system of reimbursement of medicines in Ukraine.

In 2014-2015, fulfilling USAID mandate, *Systems for Improved Access to Pharmaceuticals and Services* (SIAPS) Program in Ukraine, implemented by Management Sciences for Healt (MSH), developed a draft regulatory and legislative framework to establish an updated National Essential Medicines List (NEML), in line with modern requirements of European legislation. It is expected that the updated National Essential Medicines List will become the sole basis for public procurement in 2017 and the list will also serve as the basis for reimbursement for pharmaceuticals.

Some initial steps were taken to develop a medicines reimbursement system, at the end of 90s, when Cabinet of Ministers approved Decree N 1303 (On the Regulation of Free and Subsidized Sale of Drugs).

Subsequently, first attempts were made to establish the reimbursement mechanisms, through the introduction of two pilot projects involving anti-hypertensives (2012) and insulin (2015). However, the experiments were not perceived as a success by all stakeholders.

The implementation of the mechanism for reimbursement of medicines included in EML will constitute the basis for transparent processes of ensuring access to medicines, mitigate the scope for corruption, improve quality of care, and support cost-effective use of limited resources in Ukraine.

### A. Scope

The purpose of the assignment is:

- IV. Participation in the sessions of Working Group on Drug Reimbursement Mechanism Implementation, meetings;
- V. Legal support of the EML Expert Committee and Ministry of Health of Ukraine (MoH) for official approval of the NEML.

#### C. Contract Term/Period of Performance

The term of the contract issued as a result of this solicitation shall be September 18, 2016 – June 30, 2017.

#### D. Payment Terms

Payment terms for the contract issued as a result of this solicitation shall be 10 days payment on service delivery and signing of Acceptance Certificate. Payment to the selected offeror for services rendered shall be made via EFT to the bank account provided by the offeror. MSH is willing to consider any offerors proposed method of billing for services, including frequency of payments, provided that the proposed method does not include pre-payment for services not yet completed.

#### II. REQUIRED QUALIFICATIONS

In order to be selected for award the offeror must have the following qualifications:

The local legal firm with

- 1. More than 5 years of experience of working in health care and pharmacy legislation;
- 2. Experience in drafting Ukrainian legislation based on international best practices;
- 3. Evidence of previously drafted regulatory documentation currently in use in the health care sector;
- 4. Experience in the development of regulatory and legislative documents to reform healthcare system especially to Essential medicines selections;
- 5. High level of English language proficiency.

## A. Contents of Proposals

Offerors shall submit their proposals as two separate files. One shall be titled *Technical Proposal* and the other shall be titled *Cost Proposal*.

#### 1. Technical Proposal

Offerors Technical Proposal shall include all of the following:

- a) Completed & signed Attachment A Proposal Cover Sheet
- b) Statement indicating any objections to MSH's Standard Terms and Conditions of Supply viewable at <a href="www.msh.org/about-us/doing-business-with-us">www.msh.org/about-us/doing-business-with-us</a> that would need to be settled in order for the offer to accept a contract from MSH.
- c) Name & contact information for at least 3 current or previous clients that can serve as references for the offeror.

Note: Failure to provide any of the information requested above will result in rejection of the proposal.

#### IV. EVALUATION OF OFFERS

#### A. General Information

MSH anticipates receiving at least one round of questions from potential vendors; however MSH reserves the right to award a contract without discussions.

Each offer submitted will be reviewed by an evaluation committee consisting of MSH employees in accordance with the criteria below and award will be made to the responsible vendor whose offer represents the best overall value to MSH.

#### **B.** Evaluation Criteria

Award will be made to the offeror whose proposal, conforming to the solicitation, is determined to offer the best value to MSH. Offers will be evaluated as follows:

- 1. Ability to meet the Scope of Work
- 2. Possession of all "Required Qualifications" listed above
- 3. Price
- 4. Past performance/references

Factors are listed in order of importance.

#### C. Determination of the Competitive Range and Contract Award

If MSH determines that discussions are necessary, a Competitive Range will be established which is composed of only the most highly rated offers. MSH may exclude an offer if it is so deficient as to essentially require a new proposal. Should a competitive range be established, MSH may invite those in

the competitive range to present their offers to the evaluation team. Should oral presentations occur, they will be evaluated as part of the offer.

## D. Non-Profit Pricing

MSH is a registered 501(c)(3) non-profit corporation. Offerors should provide any and all discounts available to MSH based on its status as a U.S. Government contractor and as a non-profit.

#### E. Acceptance of Offer and Award

This RFP is non-binding and in no way obligates MSH to award any contract. MSH reserves the right to make an award in whole or in part, or not to make an award, in accordance with the best interests of MSH. Firm commitment to purchase is not established until a written order/contract is issued by MSH.

## F. Cost of Proposal Preparation

The cost of the proposal preparation in response to this solicitation shall be solely the responsibility of the Offeror.

## **G.** Validity of Offers

Offers submitted in response to this solicitation shall be valid for at least 90 days from date of submission. Prices quoted by the offeror and subsequently incorporated in contract resulting from this solicitation shall be valid for the full period of performance.
